The Police Athletic League (ISCC/PAL-IL) is a non-profit guided youth organization, with a mission to reduce juvenile delinquency and promote positive interaction between law enforcement and communities. In essence it is a recreation oriented juvenile crime prevention program that relies heavily on athletics and recreational activities to tighten the bond between police officers and kids in the community.

A PAL program brings youngsters under the supervision and constructive influence of a responsible law enforcement agency and expands public awareness about the role of a police officer. That role is the positive reinforcement and support of the responsible values and attitudes instilled in young people by their parents.

Youth sports programs have contributed significantly to the reduction of delinquency in our communities. Police Athletic League's, use athletic and recreational programs as a tool; a way to involve children in the program. While involved with PAL, the message of avoiding gangs, drugs, alcohol, and other detriments, is discussed with the youngsters. Although nationally known as a recreation program, the Police Athletic League has adapted to the changing times. PAL programs now incorporate programs such as business exposure and skills training, mentoring, and homework help, to further aid our children.


